Terms and Conditions

Please read the following terms and conditions carefully. You must not make any booking unless you understand and agree with the following terms and conditions. References to “us”, “we” and/or “our” in these booking terms and conditions shall mean Arcus Adventures. We will rely on the authority of the person making the booking to act on behalf of any other traveller on the booking and that person will bind all such travellers to these terms and conditions.

CODE OF CONDUCT

The success and enjoyment of your holiday depends on you and others behaving in an appropriate and responsible manner. It is a condition that your conduct is compatible with the well-being and general enjoyment of others on your holiday. You agree to accept the authority of Arcus Adventures staff and resort and tours staff and comply with their authority and their directions. Arcus Adventures has a zero tolerance to illegal drug use and possession, intoxication, threatening or abusive behaviour, both physical and verbal, and property vandalism. If, in the absolute opinion of Arcus Adventures staff your behaviour breaches this code of conduct then Arcus Adventures will remove you from the trip. If this occurs, you will be responsible for your own return transport costs and you will not be entitled to any refund for the unused portion of your holiday. You also agree that you will have no claim against Arcus Adventures or associated lodgings or tour staff.

PASSPORT AND VISAS

Arcus Adventures advise that all travellers must have a valid passport for international travel and require at least 6 months validity from the date of return. It is important that you ensure that you have valid passports, visas and re-entry permits which meet the requirements of immigration and other government authorities. Any fines, penalties, payments or expenditures incurred as a result of such documents not meeting the requirements of those authorities will be your sole responsibility. If you need information regarding visas, passports and other travel document requirements for your trip, please let us know. We can provide you with general information on visa and passport requirements that apply to your international travel booking.

If you are travelling to the United States, please see <https://esta.cbp.dhs.gov> for important information regarding compulsory pre-registration for their visa

waiver program (“ESTA”). Australian passport holders will not be able to enter the United States without a valid ESTA (or visa). Please note, you may not meet the eligibility requirements of ESTA and may be required to obtain a visa. All extra incurred travel expenses will be the responsibility of the traveller.

PRICES

All prices that we quote are in Australian Dollars and are subject to availability and can be withdrawn or varied without notice. Due to constantly fluctuating exchange rates, tour prices are fixed only in US dollars. Please note that prices quoted are subject to change. Price changes may occur due to matters outside our control which increase the cost of the product or service. Such factors include adverse currency fluctuations, fuel surcharges, taxes and airfare increase. Even if paid in full, a price may change because of matters outside our control.

DEPOSIT, PAYMENTS & REFUNDS

You will be required to pay a deposit of \$2,000/person when booking. All deposits are non-refundable for changes of mind or cancellations by you (subject to your rights under the Australian Consumer Law). Final payment is required no later than 20 weeks prior to departure unless otherwise stated. All payments to be made electronically into a designated Arcus Adventures bank account. **Once final payment is made there will be no refund.** Payments made by direct deposit may take up to three business days to process. You will need to make the payment at least three business days prior to the actual due date.

ITINERARY

We reserve the right to vary or cancel the itinerary, accommodation, or services nominated on the tour should circumstances warrant that such changes would be in the best interest of the client, or for any other operational reason.

SPECIAL REQUIREMENTS

You must inform Arcus Adventures regarding any special requirements you may have for your travel arrangements such as special meal and seating requests, room type or disabled access prior to making a booking. Currently we are not equipped or facilitated to handle clients with physical or mental disabilities. If you do not specifically inform us we will assume that you do not have any such requirements, and the booking will be made on that basis.

LUGGAGE/BAGGAGE

Any additional charges for luggage will be the responsibility of the traveller. Arcus Adventures will not be held responsible for any loss or theft of baggage or belongings.

HEALTH & FITNESS

A certain level of fitness will be required as we will be doing some moderately demanding activities and sometimes in low and high temperatures... and high altitudes.

PRIVACY POLICY

We are committed to protecting your personal information. By providing personal information to us, you agree that we may handle your personal information and you consent to us collecting, using and disclosing your personal information. You agree that in certain circumstances (such as where you request us to book international travel for you), we are permitted to disclose your personal information to overseas recipients. Such recipients may include the overseas travel service providers (e.g. airlines, accommodation or tour providers) with whom you make a booking. These travel service providers will in most cases receive your personal information in the country in which they will provide the services to you or in which their business is based. We may also disclose your personal information to our overseas related entities and to service providers who perform services for us within and outside of Australia. Generally, we will only disclose your personal information to these persons in connection with facilitation of your travel booking and/or to enable the performance of administrative and technical services by them on our behalf. Where we disclose your personal information to any person (including any overseas recipients), you agree that we will not be required to ensure that person's compliance with Australian privacy laws or otherwise be accountable for how they handle your personal information. When used above, "disclose" includes to transfer, share, send, or otherwise make available or accessible to another person or entity.

LIABILITY

To the extent permitted by law, we do not accept any liability in contract, tort or otherwise for any injury, damage, loss (including consequential loss), delay, additional expense or inconvenience caused directly or indirectly by the acts, omissions or default, whether negligent or otherwise, of third party providers over whom we have no direct control, force majeure or any other event which is beyond our control or which is not preventable by reasonable diligence on our part. Under circumstances where our liability cannot be excluded and where liability may be lawfully limited, such liability is limited to the remedies required of us under

applicable law (including the Australian Consumer Law). We disclaim any liability for any consequential loss, including loss of enjoyment or amenity. This liability clause is subject to your rights under the Australian Consumer Law and nothing in these terms and conditions is intended to limit any rights you may have under the Competition and Consumer Act 2010 (Cth).
